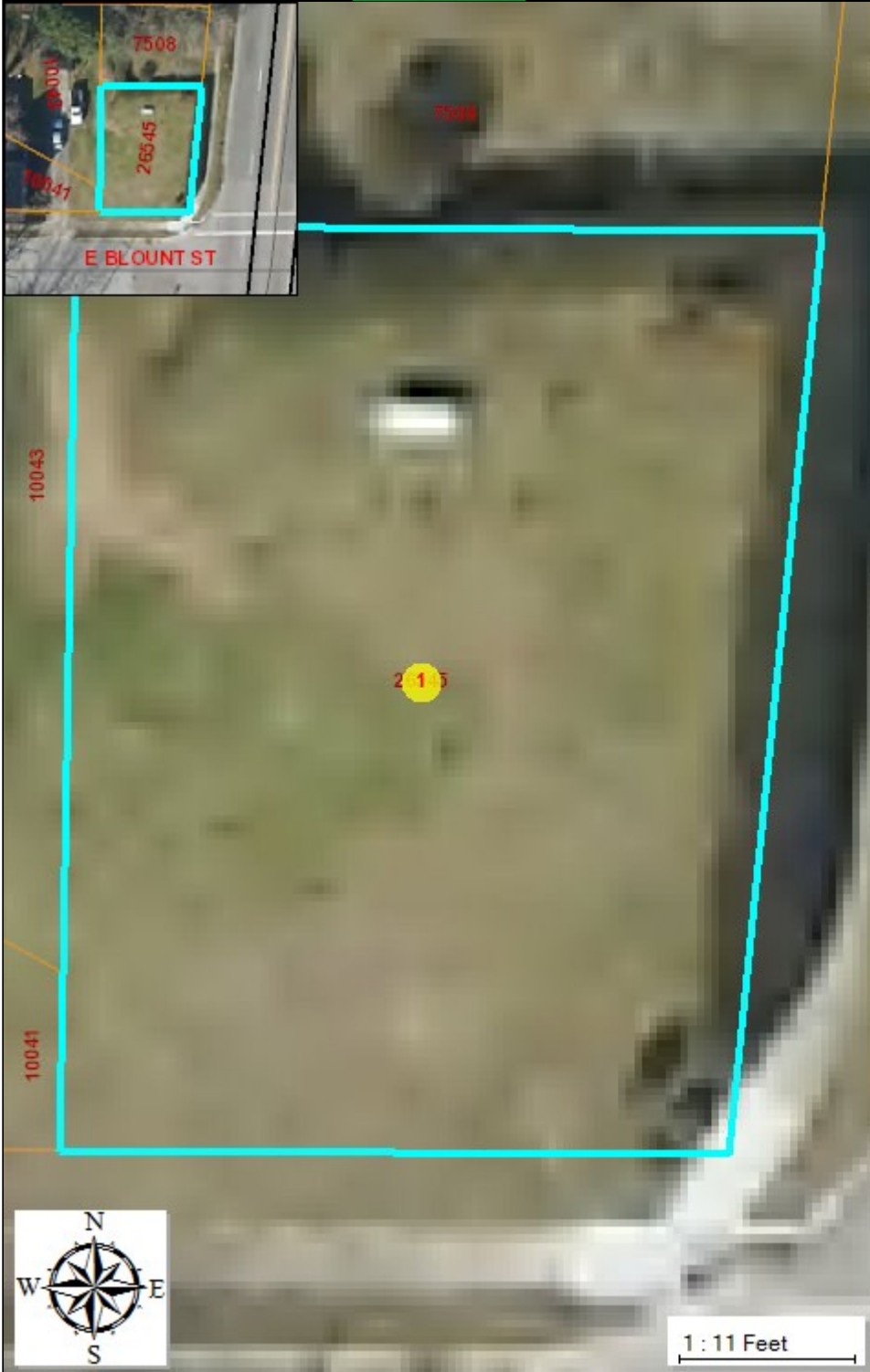

THIS DEED, made this 9th day of April, 1968, by and between Dora Fuller Chadwick of Lenoir County, North Carolina, party of the first part, and the North Carolina State Highway Commission, an unincorporated agency of the State of North Carolina, party of the second part;

WITNESSETH:

That for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration to her in hand paid by the party of the second part, receipt of which is hereby duly acknowledged, the said party of the first part has granted, bargained, sold, and conveyed, and by these presents does grant, bargain, sell and convey to and unto the said party of the second part, its successors and assigns, a certain lot or parcel of land lying and being in the City of Kinston, Kinston Township, Lenoir County, North Carolina, and more particularly described as follows:

BEGINNING at the northwest corner of the intersection of Blount and Dennis Streets and runs about north with the line of Dennis Street 60 feet to the Westbrook line, thence westwardly with the Westbrook line 59 feet to a stake, thence southwardly and parallel with the first line 60 feet to Blount Street, thence eastwardly with the line of Blount Street 59 feet to the beginning, and being the same lot of land conveyed by E. K. Best and wife to E. K. Patterson and others, Trustees of King David Lodge No. 24, A. F. & A. M. by deed of date January 9, 1929, and of record in Book 104, page 133, office of the Register of Deeds of Lenoir County.

TO HAVE AND TO HOLD the above described lot or parcel of land, with all privileges and appurtenances thereto belonging, unto it, the said party of the second part, its successors and assigns, in fee simple forever.

And the said party of the first part, for herself, her heirs and assigns, executors and administrators, covenants with the said party of the second part, its successors and assigns, that she is seized of said premises in fee, and has the right to convey the same in fee simple; that the same are free and clear from all encumbrances, and that she will forever warrant and defend the title to the same against the lawful claims of all persons whomsoever.
